 - (ii) Guarding of vulnerable bridges.
 - (iii) Running of pilot or patrol special or Goods trains ahead of a passenger train when trouble on e section is specially apprehended.
 - (iv) Burring of fishbolts whereby after the nuts are tightened on the bolt, the threads are destroyed and the bolt cannot be removed without using a chisel.
 - (v) Reducing the number of fish-plated joints by welding of joints which also improves riding quality.
