THE DEPUTY MINISTER IN THE MINISTRIES OF EDUCATION AND CULTURE AND SOCIAL WELFARE (SHRI P. K. THUNGON): (a) and (b) Under the Schsme of Short Stay Homes for women and girls, out of 15 Short Stay Homes, 12 (Patna, Gwalior. Hooghly, Trivandrum, Hyderabad, Bombay, Madurai, Imphal, Jullundur, Cuttack, Panjai, Jaipur (1983-84) are being run by the Association for Social Health in India, New Delhi and 3 [Nagpur, Malagaon (Nasik), Kalsi (Dehradun)] by the Bharatiya Adimjati Sevak Sangh, New Delhi. A list of the Office bearers of these organisations associated with these Homes is at Annexures I & II.

(c) The evaluation of the working of these Short Stay Homes is under process. The expenditure incurred during the last 3 years on the Short Stay Homes is indicated below:—
