On the recommendations of the Central Team and its consideration by the High Level Committee, a ceiling --«£-Central assistance of Rs. 33 77 sanctioned. further crores was Α ceiling of Rs. 5.69 crores was sanctioned to the State for drought relief in the month of October, 1983. The State was also sanctioned a ceiling of assistance of Rs. 1 crore, besides a series of measures of rehabilitation rejuvenation of commercial crops.
