THE DEPUTY MINISTER IN THE MINISTRY OF COMMERCE P. A. SANGMA): (a) The Fourth Session of the Inter Governmental Group of Experts on Tea met at Geneva from 6th to 13th October, 1983. In addition, meeting of Experts from Tea Exporting Countries on Minimum Export Standards was held at Geneva from 3-5 October. 1983. These meetings were held under the Integrated Programme for Commodities of UNCTAD.

- (b) The tea producing countries which attended these meetings were Argentina, Bangladesh, Brazil. Burundi, China Equador, India, Indonesia. Malawi, Mauritius, Tanzania, Zaire Zimbabwe. In addition some major tea importing countries also attended the meetings.
- (c) While most countries reaffirmed their support for I S O Standard 3720 prescribed by the International Standardisation Organisation, the meeting on Minimum Export Standard for tea did arrive at any final decision.

- (c) whether it is also a fact that ona of the officers involved in the theft has been favoured rewarded with trip to University of Leeds (UK); and

THE DEPUTY MINISTER IN THE MINISTRY OF TOURISM AND CIVIL AVIATION (SHRI ASHOK GEHLOT): (a) to (d) No, Sir. In October 1983, two ITDC officers were unable to produce requisite gate passes for taking out two telephone sets from Hotel Akbar. Realising that proper procedure was not followed, the instruments were handed over by the officers to the Durban. A Depart. mental inquiry was conducted and ITDC management 'censured' the cerned officers for their lapse. Meanwhile, in response to a circular received from the BPE, ITDC forwarded applications for a short-term training course called Improving Efficiency training and internal consultancy' at the University of Leeds, UK. One of the applicants happens to be an officer who was also involved in the incident of October, 1983.
