

**Imported goods of ITDC lost in a Fire
in Madras Port Trust Godown**

Will the Minister of TOURISM AND CIVIL AVIATION be pleased to state:

(a) whether various goods imported by the India Tourism Development Corporation and stocked in the Madras Port Trust Godown were destroyed in a fire in June, 1982;

(b) if so, what was the total loss suffered by the India Tourism Development Corporation on this account;

(c) whether the goods were insured; if so, what was the amount in terms of value received from the insurance company; and

(d) the details of the items which were destroyed?

THE DEPUTY MINISTER IN THE MINISTRY OF TOURISM AND CIVIL AVIATION (SHRI ASHOK GEHLOT):

(a) to (c) The value of goods involved in the fire accident is of the order of Rs. 20.40 lakhs. The suppliers have since* agreed to replace goods worth Rs. 1.17 lakhs. Claims in respect of insured goods are under correspondence with the Insurance Companies.
