**THE DEPUTY MINISTER IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (MISS KUMUDBEN M. JOSHI):** (a) No firms under the names M/s. Associated Chem. and Associated Traders, Kirti Nagar, Delhi are licensed to manufacture drugs by the Drug Control Department of Delhi Administration.

M/s. Associated Pharma, Kirti Nagar, New Delhi is licensed to manufacture drugs under the Drugs and Cosmetics Act and Rules by the Drug Control Department of Delhi Administration. During routine inspections random checking of records of the firm did not reveal that the firm had manufactured and drug not having full formulation. No instance of sub-standard medicines having been despatched to State Governments had come to the notice of the officers of the Drug Control Department of Delhi Administration during their inspections. The firm has further stated that they had not despatched any drug to any State Government during the last two years.

**Medicines manufactured by M/s. Associated Pharma etc.**

**THE DEPUTY MINISTER IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (MISS KUMUDBEN M. JOSHI):** (a) No firms under the names M/s. Associated Chem and M/s. Associated Traders, Kirti Nagar, Delhi are licensed

to manufacture drugs by the Drug Control Department of Delhi Administration. M/s. Associated Pharma, Kirti Nagar, New Delhi is however, licensed to manufacture drugs under the Drugs and Cosmetics Act and Rules by the Drug Control Department of Delhi Administration. The Names of medicines allowed to be manufactured by M/s. Associated Pharma Kirti Nagar, New Delhi on their licences on forms 25 and 28 are enclosed at Statements I and II respectively. [See Appendix CXXVIII Annexure No. 112].

(b) and (c) The Prices of Drugs are regulated under the Provisions of Drugs (Prices Control) Order, 1979, issued by the Ministry of Chemicals and Fertilisers. Price lists maintained by the firm are enclosed at Statements I and II. [See Appendix CXXVIII Annexure No. 113].

#### **Malda town Railway Station**

#### **Gauhati Railway Station**

**3158. SHRI ROBIN KAKATI:** Will the Minister of RAILWAYS be pleased to state:

(a) the total expenditure incurred for the development and expansion of Gauhati Railway Station for the years 1980-81 1981-82 and 1982-83 respectively; and

(b) the amount estimated for the development and expansion of Gauhati Railway Station for the year 1983-84?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI C. K. JAFFAR SHARIEF): (a) The total expenditure incurred for the development and expansion of Gauhati Railway Station for the years 1980-81, 1981-82 and 1982-83 is as under:—

(b) The expenditure expected to be incurred during 1983-84 for the development and expansion of Gauhati Railway Station building in 1983-84 is expected to be approximately Rs. 2.82 lakhs. This excludes the cost of yard remodelling in connection with provision of new Broad Gauge line upto Gauhati.

#### Complaints from States in regard to non-supply of essential commodities

THE DEPUTY MINISTER IN THE DEPARTMENT OF ELECTRONICS AND IN THE MINISTRY OF FOOD AND CIVIL SUPPLIES (SHRI M. S. SANJEEVI RAO): (a) and (b) The States of Andhra Pradesh, Tamil Nadu, Kerala, Karnataka, West Bengal, Orissa and Madhya Pradesh had requested for extension of time to lift their back-log to edible oils for the last oil years 1982-83. The lifting of the back-log of 1,08,370 Mts. of edible oils was permitted by the

Government in the case of these States till the end of November, 1983.
