Despite this, however, the officers have been given ad hoc grants and reliefs on more than one occasion, keeping the overall interest of the Corporation in view. Since the amendment to the L.I.C. Act, 1981; the power to frame regulations governing the terms and conditions of services of the employees of the L.I.C. rests with the Government. Action in granting increases in D.A. etc. to officers has been challenged in the Supreme Court and the matter is sub iridice.
