THE MINISTER OF RAILWAYS (SHRI A. B. A. GHANI KHAN CHAUDHURI): (a) to (c) overall progress of the work is 15.5 per cent. The progress was somewhat hampered due to malarial conditions, disturbed law and order situation in the last working season resulting in failure of some contractors-17 lakhs cums of earth work has been done against 44 lakh cums. The work is going on in spite of adverse working conditions.

THE DEPUTY MINISTER IN THE DEPARTMENT OF ELECTRONICS (SHRI M. S. SANJEEVI RAO): (a) and (b) The total stock of foodgrains with the Food Corporation of India as on 31st March, 1983, was about 9.13 million tonnes. The grain-wise break up is given below:

- (c) As the kharif marketing season 1983-84 (Oct.-Sept.) will commence only from 1st October, 1983, no precise estimate for the procurement of kharif cereals can be given at this stage. As regards rabi cereals for the marketing season 1983-84 (April—March), a record procurement of 82.16 lakh tonnes of wheat has been made as reported upto 30th July, 1983. As the m ain procurement season is already over, only a small quantity of wheat is expected to be procured in the remaining period of the season.
- (d) On the recommendations of the Technical Group on buffer stocking

policy constituted in 1975, the Government decided to maintain a buffer stock of 12 million tonnes over and above the operational stock with a composition of wheat and rice at 75.25 for the present.

- (e) The value of 12 million tonnes of buffer stocks would be about Rs. 2300 crores.
- (f) Total interest charges estimated to be incurred by the Food Corporation of India during 1983-84 are Rs. 341.17 crores (on bank overdraft Rs. 312.00 crores and the Government of India loans and others Rs. 29.17 crores). Total storage charges estimated to be incurred for foodgrains during 1983-84 are Rs. 94.96 crores and handling charges Rs. 59.81 crores. It is difficult to estimate the value of natural wastage.

THE MINISTER OF STATE IN THE MINISTRY OF IRRIGATION (SHRI RAM NIWAS MIRDHA): (a) A statement showing the creation of additional irrigation potential Statewise during 1980-81, 1981-82 and 1982-83 is enclose (Statement-I).

- (b) The total cultivable area in the country has been assessed as 186 million hectares. The whole of it cannot be covered by irrigation. The ultimate irrigation potential has been assessed as 113.4 m.ha. Upto June, 1980 a potential of 56.5 million hectares has been created. A State-wise break-up is enclosed (Statement-II).
- (c) A statement is attached (Statement-III).
