## Doctors/Nurses leaving jobs for going abroad

THE DEPUTY MTNISTER IN THE OF HEALTH MINISTRY FAMILY WELFARE (MISS KUMUD-BEN M. JOSHI): (a) Doctors and Nurses do not normaly cite the reason for leaving their jobs. On the basis of the information available, one doctor and' one staff Nurse from the Lok Nayak Jayaprakash Narayanan Hospital and one nurse "mm the New Delhi Municipal Cornoration have left their jobs in Delhi hospitals and taken up jobs abroad in 1982-83.

(b) Prescribed procedures are being followed to fill up vacancies.

## Restrictions on visits to Railway **Platforms**

THE MINISTER OF RAILWAYS (SHRI A. B. A. GHANI KHAN CHAUDHURI): (a) and (b) Yes. In order to eliminate over-crowding at platforms and unauthorised persons getting into the trains at the last moment a scheme has been introduced, as an experimental measure, to restrict entry of persons other than the bonafide passengers on platform No. 1 at Madras Central railway station at the time of der>arture of 15 Dn. G. T. Express «nd 121 Dn. Tan-Nadu Express trains. Platform ket Holders accompanying children, ladies without escort, patients, physically handicapped and aged persons are permitted alongwith bonafide passengers under this scheme. A similar scheme has also been introduced at New Delhi railway station at the time of departure of 122 Up Tamil Nadu Express w.e.f. 26-7-1983.

(c) A marginal fall to the tune of Rs. 35,417.50 in the sale proceeds of platform tickets at Madras Central station during the period February, 1983 to June, 1983 has been noticed as compared to corresponding period of last year. It may be added that this fall in the sale of platform tickets may not be entirely due to the above mentioned scheme. However, the scheme has been welcomed by the general public and the advantages flowing from it in the shape of orderliness at the platform, convenience to th» bonafide passengers and control over the activities of anti-social elements out-weigh the financial considerations.
