Fire in P.GJ., Chandigarh

- (a) the damage caused to the Library in terms of books and damage to the building in the recent fire accident in Post-Graduate Institute of Research Medical Education at Chandigarh;

- THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND (SHRIMATI FAMILY WELFARE MOHSINA KIDWAI): (a) About 20 per cent of the books and about 60 per cent of journals were destroyed in the fire which broke out in the research block (Library portion) of the Post-Graduate Institute of Medicai Education and Research Chandigarh, on the 30th June, 1983, besides extensive damage to the building.
- (b) and (c) The local police is inquiring into the matter and their report is awaited.
- (d) Since the reinforced concrete frame structure of the building has been affected by the fire, advice of the Central Building Research Institute, Roorkee, has been sought for carrying out the repairs. Efforts are being made to locate additional funds for replacement of books and journals destroyed in the fire.
