THE MINISTER OF **PLANNING** (SHRI S. B. CHAVAN): (a) and (b) Based on provisional estimates of sectoral growth rates and information on other relevant variables, rough estimates employment in terms of standard person-1981-82 indicate that growth rate of total employment in terms of standard personyears was 4.4 per cent in 1980-81 and 3.3 per cent in 1981-82. Corresponding estimates for 1982-83 have not been worked out as official estimates of sectoral growth of the economy for this year are not yet available. The Sixth Plan estimated the likely annual growth rate of employment in terms of standard person-years at about 4.2 per cent for the whole economy. Separate estimates for the public and private sectors are available.

According to the data furnished by the Director General of Employment and Training, Ministry of Labour, the employment in the organised sector recorded a growth rate of 2.7 per cent in March 1981 over March 1980 and 3.0 per cent (Provisional) in March 1982 over March 1981 in the public sector, corresponding growth rates for the private sector being 2.3 per cent and 2.9 per cent (provisional) respectively. Similar figures, for March, 1983 are not available.
