(b) and (c) The Sri Lankan Foreign Minister discussed the situation in Sri Lanka with our Prime Minister and Foreign Minister. The Sri Lankan Foreign Minister's attention was drawn to the fact that in the ethnic violence in Sri Lanka, Indian nationals, including the Indian High Commission officials, and their houses were attacked. It was made clear to the visiting Foreign Minister that although the problem was an internal matter of Sri Lanka because of the close historic and personal ties between India and Sri Lanka the sufferings of the Tamil community in Sri Lanka was a matter of great concern and anguish for the people all over India and particularly in the State of Tamil Nadu. Our views were also explained to some of the other Foreign Ministers who were here.

The Sri Lankan Foreign Minister informed us that the Sri Lankan law enforcement agencies were re-establishing their control and would be able to assure the safety of all segments of the population.

#### **Construction of Flats for the Retired Government Employees**

#### **Allocation for small and marginal farmers**

(a) whether it is a fact that there is a provision of Rs. 250 crores in the budget for the small and marginal farmers;

(b) whether it is also a fact that matching grants are not being made by the State Governments; and

(c) what was the allocation made last year by the Central Government and what was the matching grants made by the States?

(a) A lump sum provision of Rs. 300 crore was made in the Ministry of Finance Demands for giving grants-in-aid to States on the basis of their better performance in implementing specific programmes for the benefit of weaker sections of the Community and for certain other scheme. Out of the above allocation, Rs 125 crore have been earmarked for implementing the scheme of assistance to small and marginal farmers for increasing agricultural production which represents Government of India share of roughly 50 per cent of the total outlay of Rs. 250 crores.
