## Foreign hand behind Khalistan Movement

- (a) whether it is a fact that the Prime Minister has recently said that the foreign hands are there behind Khalistan movement:
- (b) if so, what is the name of the particular country which is responsible for this movement; and
- (c) what steps Government propose to take against the country which is encouraging such movement?

THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI A. A. RAHIM): (a) to (c) Government have seen the press reports of Prime Minister's speech at a public meeting at Billawar on 23rd May, 1983 wherein she is reported to have referred to certain foreign forces being, behind a small section of extremists in Punjab.

The Prime Minister's reference to foreign forces is obviously based on the impression she gathers from information coming from various sources.
