Development of Tourism Industry in North-eastern Region

Will the Minister of TOURISM AND CIVIL AVIATION be pleased to state:

- (a) whether there is any proposal under Government's consideration to develop tourism industry in the North-Eastern region;
- (b) if so, what are the details thereof; and
- (c) if the answer to part (a) above be in the negative, what are the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF TOURISM AND CIVIL AVIATION (SHRI KHURSHEED ALAM KHAN):

(a) to (c) A comprehensive scheme for the development of tourist centres has been drawn up in consultation with the State Governments/Union Territories on the basis of travel circuit concept which envisages integrated development of 61 travel circuits covering 441 centres. Following travel circuits have been identified in States and Union Territories in the North Eastern Region:—

1. Assam

- (i) Gauhati Jungalbalahu Khaziranga - Sibsagar.
- (ii) Gauhati Sarapeta Baroma Manas.
- 2. Arunachal Pradesh

Tezpur - Bhalukpung - Bomdila - Tawang.

3. Manipur

- (i) Imphal Moirang LoktakLake Keibul Lamjao Park andback.
- (ii) Imphal Ukhrul Imphal.
- 4. Meghalaya
 - (i) Jorhat Nongooh Barapani-Shillong Mawngan Weilloi - Jakram - Weilloi - Mawsynrap - Shillong - Cherrapunji - Umtyangar -

Dawki Jowai - Nartiang - Josai -Garampani - Shillong - Haf-Passi long.

(ii) Bajengdoba - Rongram _ Tura-Rongram - Bongragir - Siju - Beghara - Balpalram and back to Tura.

Development of facilities at tourist centres falling on these identified travel circuits will be taken up in an integrated and phased manner by pooling the resources in Central, State and Private Sectors, depending upon the availability of funds and inter-se priorities.

Some specific schemes being undertaken on these 'travel circuit' in the current Plan period are as follows:-- .

(i) One youth hostel in each North Eastern State is being constructed in the Sixth Plan. The estimated cost of each project is as follows:-

- (iii) As part of its publicity programme the Department of Tourism is producing a brochure on each State in the North Eastern region this year as well as a combined brochure. It is also proposed to produce a film through the Films Division.
- (îv) Apart from the above a number of schemes relating to boating facilities, way side amenities and floodlighting of monuments is proposed in the present Plan period in centres on the 'travel circuits' mentioned above.
