Government Railway Police, Bombay registerred a case of misappropriation vide Crime No. 130/83 under Section 409|461 and 34 IPC against 2 R.M.S. staff who have since been arrested by the Police in this case and further investigations are in progress.

No. assessment of the total requirement of funds for the modernisation progrmme needed has been made.
