District Purnea armed with deadly weepons attacked Santhal Men and Women engaged in ploughing paddy field on 29-7-83. They killed two Santhals on the spot. They also attacked Santhal Tola of the same village and shot dead one Japla Soren said to be local leader of tribals and killed another Santhal Chotka Soren. Attackers killed four Santhal tribals in all and looted belongings of tribal families. They are reported to have exploded bombs causing injuries to the tribal men and women. bodies of 4 Santhal tribals killed are not traceable and are reported have been taken away by Bhatia Muslims. Dighal Bank Police Station Case No. 0052/83 under Section 147/ 148 149, 302, 201, 436, 323, 324; 325; 307 TPC and 3/4 Explosive Substance Act/27 Arms Act has been registered against 31 main accused persons and several unknown persons. 31 accused including 22 named accused The Muslims have been arrested. Superinten-District Magistrate and dent of Police reached the spot and controlled the situation. As precautionary measure two platoons CRPF and District Armed Forces have been deployed. Relief in shape of food, utencils, clothes, Kerosene oil etc. has been provided. Ex-gratia grant to families of those killed and injured persons is also being processed by the State Government.

## Mining Engineering as a subject for Civil Service examination

2567. SHRI VEERSHETTY MO-GLAPPA KUSHNOOR: Will the Minister of HOME AFFAIRS be pleased to state:

- (a) whether it is a fact that Mining Engineering has not been inincluded as one of the optional subjects for the Civil Strvice Examination conducted by the Union Public Service Commission;
- (b) if so, what are the reasons therefor; and
- (c) whether there is any proposal under Government's consideration to

include Mining Engineering as one of the optical subjects for the next Examination?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI NIHAR RANJAN LASKAR):
(a) Yes, Sir.

- (b) The scheme of the erstwhile I.A.S. etc. examination held till 1978 did not contain Mining Engineering as an optional subject. The Committee on Recruitment Policy and Selection Methods set up by the Union Public Service Commission in popularly known as Kothari mittee, to examine and report on the system of recruitment to the India and Central Services Class I & Class II (now known as Group A and Group B) followed by the Commission also did not suggest inclusion of Mining Engineering as a subject in the list of optional subjects for the Civil Service Examination
  - (c) No, Sir.

- (c) whether Government are aware that such marriages are generally not viewed favourably by the Caste ridden society and such couples face tremendous difficulties in their day-to-day life; and
- (d) what help Government render to such couples, specially to those who are in Government service, to overcome difficulties and get them settled nicely in their lives to make such marriages a success?
