(a) whether it is a fact that an expert nuclear team from Italy has recently visited India to assess the requirements of spares for Tarapur Atomic Power Plant;

(b) whether it i_s also a fact that an expert team from India had also visited Italy for the purpose;

(c) if so, the names, and statu_s of the leaders and other members. of the two teams $^{\rm and\ tn}e$ discussions held in either country and assurances given to India by th_e visiting team; and

(d) whether the spare_s to be imported from Italy will suit th_e Tarapur Atomic Power Plant; if so, when Government are going to take a decision in thi_s regard?

THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI A. A. RAHIM): (a), (b) and (d) An Italian team had visited India in the second week ot July, 1&83 for three days to discuss the question of supply of spare parts for the Tarapur Atomic Power Station. The visit of the Italiarfteam was primarily to understand our needs regarding the spare parts and to be able to give a more studied response Vhen the Indian team visits Italy in the same connection. The Indian team is likely to leave shortly. The question of the spare, from Italy suiting the Tarapur Atomic Power Station is presently being examined by appropriate authorities both in India and Italy.
