Upgradation of Dibrugarh as 'C class dty

- 3218 SHRI **JAGANNATHRAO** JOSHI: Will the Minister of HOME AF-FAIRS be pleased to state:
- (a) whether it is a fact that as per population, Dibrugarh is the second biggest town of Assam and has qualified for being upgraded as a 'C class city; nnd
- (b) if so, what are the reasons for which the said town has not been upgraded as 'C class city so far?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI NIHAR RANJAN LASKAR); (a) and (b) For purpose of classification of a ritf/towu as 'C clas_s for payment of House Rein Allowance, its decennial census population should exceed 50,000. The

population of Dibrugarh (Assam) as per 1971 census (no census was held there in 1981) exceeded this limit and, therefore, it qualified for classification as *C class for this purpose. However, as Dibrugarh was one of the towns where house rent allowance at the rates admissible in 'C class cities was already granted under special orders for such places, there was no need to classify Dibrugarh as 'C class again for this purpose.

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI NIHAR RANJAN LASKAR): (a) to (c> The question of direct elections to Pradesh Council for Andaman and Nicobar Islands was raised in the meeting of the Home Minister's Advisory Committee for the Islands held on 31.1.1983. It was explained in the meeting that the present system was introduced only in 1981 and it would be desirable to continue the present system for some more time before any change could be thought of.

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI NIHAR RANJAN LASKAR): (a) and (b) No such communication has been sent. However, the point was made in passing by the Prime Minister in her inaugural address at the eighth meeting of the Committee of Ministers for economic development of North-Eastern Region in "New Delhi on 26.7.1983 in which the Chief Ministers from North-Eastern States, UTs and some Union Ministers In-charge of Development Departments were also present.

(c) There have been some attempts to infiltrate but security measures and vigil on the border have been strengthened.

THE MINISTER OF STATE IN THI MINISTRY OF HOME AFFAIRS (SHRI NIHAR RANJAN LASKAR): (a) and (b) Under the Special Component Plan only Scheduled Caste families are assisted. According to the information received from the State Government 2.84 lakhs scheduled caste families are proposed to be covered by different income generating programmes of economic development during 1983-84. These programmes are in sectors like Agriculture, Minor irrigation, Cottage and Village Industries, Animal Husbandry etc Complete details are available in the Special Component Document.

(c) As per the particulars received from the State Government, against the target of 2.50 lakh families 2.42 lakh scheduled castes were assisted during the year 1982-83.
