Government are conscious of (he need to improve safety standards of vehicles irrespective of theft- orfcin. The government will consider this matter further in all itg aspecfs.

## Bokaja<sub>n</sub> Cement Factory in Assam

3168. SHRI AJIT KUMAR SHARMA: Will the Minister of INDUSTRY be pleased to state:

- (a) whether Government are aware of the unsatisfactory management of tho Bokajan Cement Factory in Assam;
- (b) whether its production alongwith its quality have gone down during the last five years; if so, what are the reasons therefor; and
- (c) what is the profit/loss of the factory during the years 1979-80, 1980-81 and 1981-82?

THE MINISTER OF INDUSTRY (SHRI NARAYAN DATT TIWARI): (a) The Bokajan Unit of Cement Corporation of India is being managed satisfactorily.

- (b) The capacity utilisation of the Unit during the last five years ranged from 61 per cent to 96 per cent. The quality of cement produced in this faotory satisfies the relevant 'ISI\* specifications and is being maintained consistently.
- (c) The profit earned by the Unit during 1979-80, 1980-81 and 1981-82 is Rs. 2.03 lakhs, Rs. 25.07 lakhs and Rs. 158.64 lakhs respectively.

## Financial Prospects of SAIL

July, 1983 and state what are the financial prospects of SAIL in the current year on the basis of actuals so far in each of the steel plants under the SAIL?

THE MINISTER OF STATE IN THE MINISTRY OF STEEL AND MINES (SHRI N. K. P. SALVE); In 1983-84, duction during the first quarter in 'SAIL plants suffered on account of severe restrictions on power supply and poor quality and inadequate availability of coking coal. The level of stocks was high due to accumulation in 1982-83 but there has been some decline in recent months. These factors have had an adverse effect on SAIL's profitability and on present indication, SAIL is likely to incur losses. Detailed analyses are in progress to identify all the measures that must be taken to improve the performance.
