THE DEPUTY MINISTER IN THE MINISTRY OF WORKS AND HOUSING (SHRI MOHAMMED USMAN ARIF): (a) Delhi Development Authority have stated that no such survey has been conducted by them.

(b) Municipal Corporation of Delhi have stated that malaria situation in Vishwas Nagar and Bhikam Singh Colony is not alarming and is well under control. No other diseases are spreading in that area.

(c) Municipal Corporation of Delhi has stated that following measures have been taken to control the mosquito unisance in these Colonies: —

1. Spray of larvicides in the stagnant water once a week.

2. Anti adult mosquito measures are being carried out by fogging with malathion and pyrethrum spray operations.

3. Facilities of Blood-test for fever cases in the localities are provided and in cases of positive symptoms, medical treatment is given,

3323. SHRI DHANESHWAR MAJHI: Will the Minister of WORKS AND HOUSING be pleased to refer to the reply to Unstarred Question No. 1439 given in the Rajya Sabha on the 5th August, 1983 and state:

(a) whether it is a fact that all the dependents of the deceased employees of the Government of India Press Minto Road, New Delhi who

passed Higher Secondary examination have not been provided with Group 'C' posts and instead they have been offered Group 'D' posts:

(b) if so, what are the reasons therefor and by when they are likely to be offered Group 'C' posts in conformity with their qualifications;

(c) whether Government have received any representation in this regard;

(d) if so, what action has been taken thereon: and

(e) if the answer to part (d) above be in the negative, what are the reasons therefor?

THE DEPUTY MINISTER IN THE ! MINISTRY OF WORKS AND HOUSING (SHRI MOHAMMED USMAN ARIF): (a) Yes, Sir.

(b) According to the general instructions of the Government, employment on compassionate grounds is given on a particular post if the applicant is eligible and suitable for the same in all respects. The suitability of the eligible persons for compassionate appointments to group 'C' posts in the Government of India Press, Minto Road, New Delhi, was therefore, tested and only those who were found fit were offered group 'C' posts and the rest group 'D' posts.

(c) to (e) Some representations were received in the Directorate of Printing, and the same were duly considered, but it was not found feasible to appoint such persons to group 'C' posts as they were not fit to hold them.
