Contribution of Agricultural Research in increased food production

- (a) what are the prospects for agricultural production this year:
- (b) what is the contribution of agricultural research in increased food production; and
- (c) whether the increased food production was achieved due to increasing irrigation and fertilizer supply or due to recent advances in the agricultural research?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI ARIF MOHD KHAN): (a) It is too early to make an assessment for the whole year at this stage. However, the prospects of kharif crop are good.

(b) Agricultural Research has played an important role in increasing

foodgrain production in the country. The major contribution has been the improvement of productivity of crops through varietal upgradation, sound crop husbandry, better crop sanitation and minimal crop losses at harvest and post harvest stages, and also developing different cropping systems.

(c) Agricultural production in a particular year depends on a number of factors such as weather, supply of irrigation water, use of important inputs like fertilizers, seeds of high yielding varieties, plant protection measures and advances in agricultural research, etc. Therefore, it is not possible to isolate the precise effect of any one particular factor on agricultural production.
