In regard to RSC/Allahabad these are being looked into by the Vigilance Organisation and the case will be referred to CBI in case outsiders are involved.

(c) So far as the question of action to be taken against guilty persons in concerned, the same will be taken according to the findings of the CBI/Vigilance.

Regarding the functioning of Railway Service Commissions, instructions have already been issued for streamlining the procedure to be adopted in conducting selections by the Railway Service Commissions.

Failure to cure insane persons

*58. SHRI J. P. GQYAL: Will the Minister of HEALTH AND FAMILY WELFAPE be pleased to state:

- (a) whether it is a fact that eight out of ten persons admitted to mental hospitals never come out cured and remain insane forever as reported in the 'Indian Express' of the 21st June, 1983 under the heading 'Mental hospitals do not cure 8 out of 10'; and
- (b) if so, what are the reasons therefor and what remedial measures are proposed to be taken in this regard?

THE MINISTER OF HEALTH AND FAMILY WELFARE (SHRI B. SHAN-KARANAND): (a) and (b) In recent years, advancement of biomedical knowledge and availability of better drugs have enabled more effective treatment of mental disorders generally as well as in mental heipitals. In the light of these developments, the general position in mental heipitals is not as has been reported in the news item.

Raising funds for the Railways through "honds" from the Public

*59. SHRI R. R. MORARKA: Will the Minister of RAILWAYS be pleased to state:

(a) whether the Railways have completed its study about the advisability of

raising funds from the public through "bonds" for financing its capital expenditures;

- (b) if so, what has been conclusion of this study; and
- (c) whether any decision has been taken in this matter?

THE MINISTER OF RAILWAYS (SHRI A. B. SHANI KHAN CHAUDHURI): (a) to (c) The matter is under examination.
