India have been given in more detail in the Annual Reports of the Department of Space for years 1979-80, 1980-81, 1981-82 and 1982-83, copies of which are available in the Parliament Library. India is one of the few countries which has active programmes in the field of Space.

(b) India has demonstrated its ca pability launching satellites from through own territory the launch of the Rohini Satellites by India's Satellite Launch Vehicle, SLV-3 dur 1980, May 1981 July and April 1983. These satellites were of the 40 kg. class. However, for launching of bigger satellites like Aryabhata, Bhaskara I & II. APPLE and INSAT, India depended has on foreign countries Government ha. approv ed two launch vehicle projects, with capability launch one a to satellites Of 150 kg. class in the near earth orbit (Augmented Satellite Launch Vehicle - ASLV) and another powerful launch vehicle capable of launching satellites of TuOO kg. class in near earth polar orbits, (Polar Satel Vehicle-PSLV). lite. Launch Work these projects is progressing. ASLV scheduled for launch in 1984-85 and the PSLV in 1987-88.

(c) The Indian Space Programme has clear objectives from the begin main ning. The aim of the pro gramme is to use space technology in self-reliant manner for various national tasks especially for enhance ment of satellite communications and for the survey and management of na tural resources. Aryabhata helped to acquire experience in satellite tech terms of design, develop nology in ment fabrication and in-orbit per formance of the various sub-systems The Rohini satellites launched from the country were to test.the perform ance of the satellite launch vehicle

and laso to do certain technological experiments. The two Bhaskara satellites provided experience in the development and fabrication of remote sensing satellites and in utilisation of data. The APPLE satellite has provided experience in designing and fabricating geo-stationary three axis stabilised communication satellites for applications. The INSAT-I Space-ci'aft, which is an operational system, will enhance the telecommunications, Radio/TV Broadcasting and weather forecasting capabilities.

On the results of Indian Forest Service Examinations 1981 and 1982. 109 candidates were appointed each year in 1982 and 1983.
