

from PDS in respect of levy sugar allotments from July, 2000 onwards.

Monthly allocation of imported RBD Palmolein is being made as per the demand intimated by States"UTs w.e.f. February, 2000. The basis of allotment to the beneficiaries through the PDS outlets is fixed by the States"UTs themselves.

Allocation of kerosene is made on historical basis i.e., past years supplies plus additional allocation out of increase given at national level. Possible increase is given out of the additional availability at the country level, in accordance with a formula under which higher allocation out of additional quantity, is given to States with lower per capita availability so as to reduce inter-state disparity over a period of time. The distribution of kerosene and its monitoring within the State is the responsibility of concerned State Government. Government of India has insisted upon the State Governments identifying ration card holders having LPG connections for discontinuance of supply of kerosene to them under PDS.

THE MINISTER OF STATE IN THE MINISTRY OF CONSUMER AFFAIRS AND PUBLIC DISTRIBUTION (SHRI V. SREENIVASA PRASAD): (a) Till 30th June, 2000 a total of 110 sugar mills had been in operation during sugar season, 1999-2000.

(b) The annual turn over in terms of sugar production of above sugar mills in Uttar Pradesh for the sugar season 1999-2000 was 45.76 lakh tonnes.

(c) The details of the sugar mills pertaining to cooperative sector of the State of Uttar Pradesh which functioned during 1999-2000 season are given in the Statement *(See below)*.

(d) to (f) Central Government does not propose to set up sugar mills in any sector including cooperative sector in the country. Further, the sugar industry has been delicensed and thus, the entrepreneurs are now free to set up new sugar mills as per the techno-economic viability of their projects while maintaining a distance of 15 kms.
