Sir, the point for which I am arising is the impending retrenchment notices which have been issued to 30,000 workers of 40 iron ore mines, half of them Adivasis, in the Badajamunda sector of the two Orissa districts of Keonjhar and Sundargarh. Sir, this news appeared in the Statesman' also of April 23, 1983. Sir all the workers have received notices from both the public sector and the private sector mineowners that there will be no production in any one of these mines from 1st of July. The reasons given in the notices. Sir. is that the Minerals and Metals Trading Corporation which was the sole purchaser of iron ore has stopped purchasing any iron ore from these mines on the ground that the importers are refusing to send their ships to the Paradip port because of the low draught and also because of other reasons. Sir, the result is that nearly two lakh people. that means, 30,000 workers and their families, will be absolutely facing starvation.

Sir, the main villain of the paece is the Minerals and Metals Trading Corporation. Sir, you will be surprised to know that these were the mines from which the the MMTC purchased 26,78,232 tonnes in 1975-76, and in 1982-83, the purchases have gone down to mere 6,15,891 tonnes. Similarly, Sir, all the public sector and private sector steel plants used, to buy iron one from these hage iron one mines in Keonjhar district, and they purchased 13,17,842 tonnes in 1980-81, while in 1982-83, it has come down to mere 9,53, 532 tonnes.

Si, if there is any defect or if the importers are refusing to send their ships to Paradip port because of the draught restriction, is it not the prime duty of the Shipping and Transport Ministry to improve the facilities in Paradip port? Secondly, Sir, Orissa is being devastated. In you have just heard Mr. Mohapatra, because of serious drought. Is it the time to throw out 30,000 workers, which Mr. Salve also talked the other day? Sir, it come erns the Ministry of Commerce which controls the MMTC, it concerns the Steel 301 RS—9

Mines Ministry which purand chases iron ore for the steel plants. and it concerns the Labour Ministry which has to give the permission for the closure of the iron ore mines. So, Sir through you, I wish to draw the attention and the attention of the three Ministries and the attention of the Prime Minister to the utterly grim situation facing Orissa. I would like to know what steps are being taken to save the jobs of these 30,000 Adivasi workers. Sir, you have just now heard that there is severe drought, food is not being supplied, money that was requested by the Orissa Government to combat drought and flood, the entire amount has not been made available. On the other hand, people who are having jobs they are being thrown out because of the closure of Badajamuda sector in Keonjhar and Sundargarh districts of Orissa. What will the workers do ? If nothing is done by the Government the will have to resort to direct action which will result in a serious law and order situation. What reply has the Government to give in this matter? Why the MMTC chose this particular juncture to stop the purchase of iron-ore resulting in the loss of jobs of 30,000 workers. So. Sir. I again plead with the Ministry that the Ministry must take steps to see that iron-ore mines are not closed down and the purchase of iron-ore continues.

REFERENCE TO THE REPORTED DECISION TAKEN BY THE INDIAN BUREAU OF MINES TO SHIFT ITS REGIONAL OFFICE FROM NELLORE IN ANDHRA PRADESH TO MADRAS

SHRI KRISHNA MOHAN BHAMIDIPATI (Andhra Pradeshi Chairman. Sir. 1 Mr. Deputy thank you very much for giving me an opportunity to make a special mention. The Indian Bureau of Mines has decided to shift the Regional Office of the Indian Bureau of Mines situated in Nellore to Madras and a part of the office has already been shifted. The Regional Office at Nellore has been giving valuable [Shri Krishna Mohan Bhamidipati] suggestions to the Mine owners in the development of their mines and also on the utility of the deposits. The region has several Mining Leases in force for barytes, limestone, asbestos and mica. Three cement plants have also been set up in Cuddapah Dirstrict with an annual capactity of a million tonnes each. The Indian Bureau of Mines has also done considerable work in the field of asbestos, barytes and mica. Over 90 per cent of deposits for barytes in India are to be found in Cuddapah District which is adjacent to Nellore District. Since the grade of the limestone is not uniform, benefication studies will have to be taken up and for all these activities, the continuance of the Regional Office at Nellore is essential.

May I, through you, request tha 1 on-Minister for Mines to see that the Regional Office at Nellore is not shifted?

"जालंधर, 5 मई-सीमा पार ने प्राप्त समाचार के धनसार पाकिस्तान ने म्सलिम यवकों को सिख वेश धारण करा कर हिंद धर्म और सिख धर्म के संबंध में विस्तृत जानकारी देकर हथियार चलाने का प्रणिक्षण दिया जा 🔭 है। पाकिस्तान सरकार ने लायलपर ब्रांर गजरां-वाला में इस प्रकार के प्रशिक्षण केंद्र खोले हमें हैं, जहां से अब तक सैंकड़ों युवक इस प्रकार का प्रशिक्षण ले च्के हैं। यह भी पता चला है कि इन युवकों को हिंदुनों भीर सिखों के धर्म-प्रम्थीं का शह पाठ करने का भी प्रशिक्षण दिया जा रहा है। इस काम के लिये वहां के ब्रिटक्यों श्रौरसिखों से सिक्रिय सहयोग भी पाकिस्तान सरकार ले रही है।"

मान्यवर, पाकिस्तान सरकार की यह कार्यवाही आजकल पंजाब में चल रहे आंदोलन में घुसपैठिये भेज कर और अधिक उम्र क्रम दिलाने के उद्देश्य से दिलाई पड़ती हैं, जो हमारे आंतरिक मामलों में हस्तक्षेप में सम्बन्ध रखता है। इस कार्यवाही से मेरा निश्चित मत है कि अकाली आन्दोलन के पीछे विदेशी शिक्तयों का हाय है।
