THE DEPUTY MINISTER IN THE MINISTRY OF COMMUNICATIONS (SHRI VIJAY N. PATIL): (a) A list of telephone exchanges. Main I Extensions to be commissioned" during 1983-84 in Delhi is given in the statement attached.

(b) and (c) About 49,000 connections are likely to be provided during 1983-84 in Delhi subject to availability of stores and materials. Number of connections to be provided from each exchange will be such as to load the exchange up tO' its connectable capacity viz., normally 90 to 94 per cent. The distribution of the connections between various categories viz., OYT, special category, general etc., will be based on norms at Annexure [See Appendix CXXVI Annexure No. 34]

Squattens colonies, of West Bengral

- 631. SHRI RAMKRISHNA MAZUM-DER; Will the Minister of LABOUR AND REHABILITATION be pleased to state:
- (a) how many squatters' (refugee) colonies of West Bengal have been approved by Central Government for regularisation and how many plot holders will be entitled to be rehabilitated on such approval;
- (b) how many squatters' colonies have not yet been approved for regularisation and what are the reasons therefor;
- (c) what are the terms and conditions for regularising these approved squatters' colonies; and
- (d) by which authority the terms and conditions for regularising the colonies have been decided?

THE MINISTER OF LABOUR AND REHABILITATION (SHRI VEEREN-DRA PATIL): (a) 149 pre-1951 and 175 post-1950 squatters' colonies have been regularised. About 46,000 plot-holders will be benefited.

(b) to (d) According to the Report of the R. R. Committee appointed by State Government of West Ben gal which been received. 956 has squatter colonies have been mention ed including the ones which have al ready been regularised as mentioned in part (a) above. No norms have yet been formulated in respect of these colonies. A view on the Report will be taken shortly.

R«fugee problem of West Bengal

- 632. SHRI RAMKRISHNA MAZUM-DER: Will the Minister of LABOUR AND REHABILITATION be pleased to state:
- Ca) whether it is a fact that Central Government have received a composite plan for completing the rehabilitation of refugees in West Bengal;

(c) The demand has several items. Each one is being examined. A view on which item should be funded by -us and to what extent will be taken shortly.

New electricity projects in West Bengal

(b) and (c) Project Report of a hydro-electric project with 700 MW -capacity and located in Darjeeling District has not been received in the Central Electricity Authority for tecimoeconomic clearance. A pre-feasibility report on Kisto-bazar pumped-storage project (1050 MW) in Purulia District was received in the Central Electricity Authority in January, 19ao, and comments thereon were forwarded to the West Bengal authorities. It was subsequently indicated by the project authorities that further detailed investigations and studies had been taken uP- Project report has not been received so far-
