Development of Mohanbari Airport

THE MINISTER OF STATE IN THE MINISTRY OF TOURISM AND CIVIL AVIATION (SHRI KHUR-SHED ALAM KHAN): (a) An amount of Rs. 2.42 crores has been sanctioned for the development of Mohanbari aerodrome in Assam and Rs. 41.20 lakhs has so far been spent upto the end of March, 1983.

(b) The contract for the work which was awarded in February 1981, has been rescinded because of very unsatisfactory progress. Fresh tenders have been invited and the work is expected to be completed in 1-1 (2 years after the work has been re-awarded).
