(a) to (e) Income-tax authorities searched the concerns of a Textile Group of Ahmedabad as reported in the Newspapers. The searches were actually conducted between 22-1-1983 and 30-1-1983 at Ahmedabad, Bombay, Bhiwani and Surat in the cases of Patel Mills Ltd., and C.T.M. Textiles of Ahmedabad, C. Lajpatrai (P) Ltd., Bombay and the Directors of these companies, Lajpatrai Chaturbhuj Shri Agarwal and Shri Mohanlal Chaturbhuj Agarwal and other connected cases. The searches resulted in seizure of prima-facie 17 lakhs. assets of Rs. unaccounted Incriminating documents indicating incoming and outgoings of 'on money' and secret protfis not disclosed for taxation purposes, seized during the searches are under scrutiny and appropriate action under various Direct Taxes Acts will be taken. There is no provision under the Income-tax Act of arrest in course of searches. Hence question of any arrest does not raise.
