THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI NIHAR RANJAN LASKAR): Ca3 and (b) It is presumed that the expression 'Minority High Power Committee' refers to the High Power Panel on Minorities, Scheduled Castes and Scheduled Tribes and otrer weaker sections. The Report of this Panel is awaited. The Minorities Commission has so far sub. mitted three Annual Reports for the year 1978, 1979, 1980 and the Fourth Report covering the period from January, 1981 to March, 1982, (the Commission have decided to shift to a financial year basis for its Reports). The first, second and third Annual Reports of the Minorities Commission together with the Action taken-Memoranda were laid on the Table of the Raiva Sabha on 9.7-1980, 22-12-1980 and 5-8-1982 respectively. The fourth Annual Report of the Minorities Commission has been received on 19-4-1983. Its printed copies have yet to be received. This Report is under consideration of the Government.
