*173. DR. LOKESH CHANDRA: DR. (SHRIMATI) NAJMA HEPTULLA:

Will the Minister of WORKS AND HOUSING be pleased to state whether any survey has been conducted in the Union Territory of Delhi to determine the total number of dwelling units and the

total requirement of houses for the present population of the Capital, if so, what are the details thereof?

THE MINISTER OF PARLIA-MENTARY AFFAIRS, SPORTS AND WORKS AND HOUSING (SHRI BUTA SINGH): The DDA has reported that as part of the preparation of Perspective Plan for Delhi-2001, the following data on house-holds were collected in 1981:—

The DDA has further reported that at present it is estimated that there is a shortage of about 3 lakh dwelling units.

Amendment to the Port Trust Act *174. SHRI LADLI MOHAN NIGAM:

Will the MINISTER OF SHIPPING AND TRANSPORT be pleased to state:

(a) whether Port, Dock and Waterfront Workers Federation of India have urged Government to amend the Port Trust Act to restore authority and autonomy of the Port Boards; and

(b) if so, what are the details thereof and action taken thereon?

THE MINISTER OF SHIPPING AND TRANSPORT (SHRI K. VIJAYA BHAS-KARA REDDY): (a) and (b) The Port, Dock and Waterfront Workers have sent

a representation received on 14-4-83 stating that the Major Port Trusts Act, 1963 was amended so as to deprive the Port Trust Boards of their powers and the same are now vested in the Chairman of the Port Trust Boards and the Government. They have also requested that the Major Port Trusts Act, 1963 may be amended so as to restore the authority and autonomy or the Port Trust Boards and that Government should not give instructions to the Chairman of Major Port Trusts beyond the pow ers vested in them by the Act.

It is not correct to say that the Major Port Trusts Act, 1963 was amended so as to deprive the Port Trust Board of some powers and to vest the same in the Chairman of the Port Trust Board and the Government. The question of amending the Act to restore authority and autonomy

of the Port Trust Boards does not therefore arise.

It is also not correct to say that Government are issuing instructions beyond their jurisdiction.

शिक्षा श्रौर संस्कृति तथा समाज कल्याण मंत्रालयों में राज्य मंत्री (श्रीमती शीला कौल) : (क) जो, हां । दिल्ली प्रशासन द्वारा भेजों गई सूचना के श्रनुसार राजकीय स्कूलों में कार्य कर रहे ऐसे शिक्षकों को संख्या इस प्रकार है :—

(ख) जी, हां । दिल्ली प्रशासन द्वारा भेजी गई सूचना के प्रनुसार ऐसे शिक्षकों की संख्या इस प्रकार है:—

(ग) संवर्ग नहीं बदला जा सकता। कोई शिक्षक उस पद के लिए सीधी भर्ती के रुप में आवेदन कर सकता है जिसके लिए वह अर्हक हो और चयन हो जाने पर उसे उस वर्ग में नई नियुक्ति पर माना जाएगा। अन्य वर्ग में की गई सेवा पेंशन सम्बन्धी लाभों के लिए गिनी जाती है, लेकिन वरिष्ठता के लिए नहीं। प्रशिक्षक दो अलग-अलग वर्ग हैं जिनके लिए अलग-अलग अर्ह ताएं अपेक्षित है।

*176. SHRI P.N. SUKUL: DR. LOKESH CHANDRA:

Will the Minister of EXTERNAL AFFAIRS be pleased to state whether any joint projects by India and Kampuchea for restoration of Angkor Vat have been planned?

THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI A. A. RAHIM): Yes, A comprehensive project report on the preservation of the Angkor Vat monuments has been prepared by Indian archaeologists who were sent to Kampuchea last year. Assistance by Indian along with other countries in restoring the monuments of Angkor Vat was recommended by a team of experts led by Dr. G. V. K. Rao, former Member of the Planning Commission, when the team visited the countries of Indo-China to make comprehensive recommendations on economic, technical and scientific collaboration between India and the countries of Indo-China. Both these reports are under the consideration of the authorities concerned and final decisions are expected to be taken shortly.
