Setting wp of new fertilizer plants

- 1513. SHRI VISHVAJIT PRITHVIJIT SINGH: Will the Minister of CHEMICALS AND FERTILIZERS be pleased to state:
- (a) whether it is a fact that a large sum of rupees seven thousand to eight thousand crores is going to be spent in the next four to five years on new fertilizer plants and modernisation of the existing plants; and
- (b) if so, what are the States in which the new fertilizer plants will be set up and whether India will achieve self-sufficiency in the produc tion of fertilizers after these new fertilizer units have been installed?

THE MINISTER OF CHEMICALS AND FERTILIZERS (SHRI VASANT SATHE): (a) and (b) The present estimated total cost of the new fertilizer plants under construction at Tha!, Namrup (Namrup. III), Paradeep in the public sector and Hazira in the cooperative sector is Rs. 2512 crores. Besides, the new public sector gas based plant in Guna (Madhya Pradesh) is estimated to cost over Rs. 600 crores. It is also proposed to set up 4 similar gas based plants in U.P. and one in Rajasthan, at a total investment of about Rs. 3000 crores

While substantial investment are being made to augment indigenous production fertilizers, achievement of self-sufficiency in this regard will be dependent on factors like level of consumption reached and the production level achieved by the existing and proposed fertilizer plants.

Employment to families of repatriates

1514. SHRI V. GOPALSAMY: SHRJ V. VENKA:

Will the Minister of LABOUR AND REHABILITATION be pleased to state:

- (a) whether it is a fact that the State Farms Corporation in Tamil Nadu has been wound up and the operation in all 10 farms at 5 centres in Tamil Nadu has been stopped;

- (b) According to the information available with the Department, at the time of closure of the Tamil Nadu State Farms Corporation there were 788 families of Sri Lanka repatriates in position. A cash compensation of Rs. 5,000 is reported to have been distributed to each family by the Government of Tamil Nadu. The Government of Tamil Nadu have also been requested to consider allotment of 3 acres of land to each family on ownership basis.

THE MINISTER OF LAW, JUSTICE AND COMPANY AFFAIRS (SHRI JAGANNATH KAUSHAL): (a) and (b) The Iriority Commission has not recommended the enactment of any new Wakf BiH. It had occasion to consider the amendments to the Wakf Act as proposed by the Wakf Inquiry Committee and it made cerain recommendations with regard to he amendments to be made In the Act. A draft Bill for amending the Wakf Act, in the light of the recommendations of the Wakf Inquiry Committee, the Minority Commission and 'the views expressed by certain Muslim M.Ps, and others, is at an advanced stage of finalization and the Bill is likely to be introduced early in the next session of Parliament

Deaths in Eastern Coal-fields

THE MINIS! ER OF STATE IN THE DEPARTMENT OF COAL IN THE MINISTRY OF ENERGY (SHRI DAT.BIP SINGH): (a) to (c). The coal boil in the country is vast and certain persons at times violate the provisions of law and indulge in illegal extraction of coal in certain areas surreptitiously, which may at times result in deaths.

(d) No compensation is required to be paid to the next of kin of the deceased in cases of deaths arising out of illegal mining.
