THE DEPUTY MINISTER IN THE MINISTRY OF COMMUNICATIONS (SHRI VIJAY N. PATIL): (a) A target of installing 8000 new telephone line_s $i^n J^{\&K}$ Stat_e is proposed for the 6th Plan.

(b) About 3000 connections have already been given. District-wise distribution upto 31.-3-1983, for tihe sixth plan is given in Annexure.

(c) 4,660 applicants as on 1-5-83 are pending for telephone connections. The capacity of the existing exchanges would be expanded where necessary, subject to timely availability of the equipment cables and other stores. A 3000-line containerise electronic exchange is also proposed for Srinagar during the Sixth Plan.

The National Film Development Corporation expects to receive about one third of net realisation from this deal

ALL INDIA RADIO

Bulk of programmes from AIR Stations are broadcast in the main language of the region concerned. For example, it will be Marathi for the Stations situated in Maharashtra and, Telugu for the Stations situated in Andhra Pradesh and so on. There is no fixed percentage for such programmes. A statement showing the names of other language_s in which programmes are broadcast from the Stations situated in the states mentioned in' the question i_s annexed at Annexure *I*.

DOORDARSHAN

Telecast of Marathi language programmes ^{are} being made only by TV Centres at Bombay and Nagpur in th₁, State of Maharashtra. While there is no fixed time allotted, the duration for which such telecasts are made would amount to about 900 minutes per week from Bombay and 325 minutes per week from Nagpur.

The percentage would work out to 66 per cent approximately so far as TV centre at Bombay is concerned. Nagpur is not an originating centre. The names of the other languages in which telecasts are originated ' are given in the Statement at Annexure II.
