(b) After the allotment of distributorships by the oil company, the delay in actual commissioning occurs on account of nonavailability of suitable land, difficulty in obtaining godown sites etc.

(c) No, Sir.

(d) Ceilings on the existing LPG distributorships were imposed with a view to ensure that cooking gas dis tributorships of different oil com panies maintain a size conducive to economic and efficient functioning of such distributorships and, at the same time, do not deprive others of the op portunity of running such distributor ships.

- 9. Mangalore
- 10. Tuticorin.

(b) The question of supply of power is being taken up regularly with the concerned State Governments. In addition, captive power plants are being planned for some of these units. Gas turbinles have been/are being sanctioned for some of these plants on an immediate basis.
