STD/ISD/PCO booths in Sikkim

1045. SHRI O.T. LEPCHA: Will the Minister of COMMUNICATIONS AND INFORMATION TECHNOLOGY be pleased to state:

(a) the details of STD/ISD/PCOs etc. running in the various districts of North-Eastern Region at present, district-wise/State-wise;

(b) the number of such booths proposed to be set up in the NER particularly in the State of Sikkim during the current year, district-wise;

(c) the details of amount spent during the last three years on the installation of booths in the state; and

(d) the steps taken by Government in this regard?

THE MINISTER OF STATE IN THE MINISTRY OF COMMUNICATIONS AND INFORMATION TECHNOLOGY (DR. SHAKEEL AHMAD): (a) Sir, as on 30-06-2006 a total of 36,420 STD/ISD/PCOs and 8,955 local PCOs provided by Bharat Sanchar Nigam Limited (BSNL), are running in various districts of North Eastern Region. Besides these 1,750 STD/ISD/PCOs

have been provided by private operators. The State-wise and Telecom district-wise details are given in the Statement-enclosed. (See below)

(b) PCOs are allotted liberally by BSNL to all the applicants who are of the age of 18 years and above, subject to technical feasibility. PCOs are on demand in most of the areas. The numbers of booths to be installed during the current year depends on the availability of applicants.

(c) and (d) STD/ISD/PCO franchisee of BSNL is responsible for the hiring/furnishing for premises, construction of booth, procurement of telephone instrument. PCO monitor etc. Only telephone line is provided by BSNL. No separate fund is earmarked for PCO lines, as these are part of the project for direct exchange lines.
