- (c) if not, what are the reasons thereof;
- (d) what specific steps are being taken by Government for the development of trade unionism among the agricultural workers?

THE MINISTER OF LABOUR AND REHABILITATION (SHRI VEERENDRA PATIL): (a) to (O Government had introduced the Trade Unions (Amendment) Bill, 1982 in the Lok Sabha on the 30th April, 1982, and this is being further processed in the current session.

(d) With a view to helping the rural workers to organise themselves into cooperatives trade unions or other forms of organisations, as may be considered necessary, a Plan Scheme envisaging appointment of honorary organisers has been taken up for implementation in 415 blocks of eight States. 224 organisers have already been appointed, trained and placed in position.
