## Filling up of posts of 'Examiners' in Calcutta Customs

### 1604. PROF. SOURENDRA BHATTACHARJEE: SHRI MAKHAN PAUL:

Will the Minister of FINANCE be pleased to state:

(a) whether Government had received any complaints regarding the results of the written tests and viva voce of the direct recruitment examination for the post of Examiners in Calcutta Customs in 1977-78;

- (b) whether the quota of direct recruits was filled through regularisation of ad hoc appointees in violation of relevant office orders of the Ministry of Home Affairs (Departmnt of Personnel and Administrative Reforms) in this regard;
- (c) whether no examination for direct, recruitment for the posts of Examiners was held prior to 1982 even though the quota for the category remained unfulfilled;
- (d) whether it is a fact that only two verties were filled through 1982 examination for direct recruitment; and
- (e) if so, whether such vacancies were ngain filled by ad hoc appointees in contravention of relevant Government orders and without any meeting of the Departmental Promotion Committees?

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI PATTABHI RAMA RAO): (a) Yes, Sir.

- (b) According to reports received from the Collector of Customs, Calcutta no vacancies in the quota for direct recruitment in the grade of Examining Officer were filled by appointment of promoted officers on a regular basis.
- (c) Examinations for direct recruitment to the posts of Examining Officer were held by Calcutta Custom House prior to 1982 till such time as such direct recruitment began to be made through SSC.
- (d) and (e) Staff Selection Commission has not yet declared the results of the 1982 examination.

### University and College Teachers within the Purview of fourth Central Pay Commission

Will the Minister of FINANCE be pleaded to state:

(a) whether Government proposed to include within the terms of reference of the Fourth Central Pay Commission the question of the revision of pay scales of College and University teachers; and

(b) if not, what are the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI PAT-RAMA RAO) (a) and The terms of reference of the Fourth Central Pay Commission have not yet been finalised. These will be settled as soon as possible after consulting representatives of Government employees. It is, therefore, pre-mature to say at this stage whether the question of revision of pay scales of college and University teachers will be included within the terms of reference of the Commission

### Shortage of Retiring Rooms at Sonegaon Airport in Nagpur

1606. SHRI LADLI MOHAN NIG-AM: Will the Minister of TOURISM AND CIVIL AVIATION be pleased to refer to the answer to Unstarred Question 901 given in the Rajya Sabha on the 2nd March, 1982 and state:

- (a) whether Government have since taken any decision to remove the shortage of retiring rooms at Sonegaon Airport in Nagpur for the transit passengers; and
- (b) if so, what are the details in this regard?

THE MINISTER OF STATE IN THE MINISTRY OF TOURISM AND CIVIL AVIATION (SHRI KHURSHEED ALAM KHAN): (a) The existing arrangements are considered to be adequate and at present there is no proposal to construct more retiring rooms.

#### Service Benefits to Outstanding Sportsmen

1607. SHRI LADLI MOHAN NIGAM: Will the Minister of DEFENCE be pleased to state:

- (a) what service benefits are given to the outstanding sportsmen in his Ministry; and
- (b) whether any percentage has been fixed for recruitment of sportsmen in his Ministry?

THE MINISTER OF STATE IN THE MINISTRY OF DEFENCE (SHRI K. P.

SINGH DEO): (a) and (b) In respect of Junior Commissioned Officers Other Ranks of the Army and equivalent in the Navy and the Air Force who are outstanding sportsmen, benefits of accelerated promotion or ante-date seniority for promotion to the next higher rank are given. In addition, in the Air Force for officers, accelerated promotion upto the rank of Squadron Leader is given to outstanding sportsmen. Junior Commissioned Officers Other Ranks and equivalent who are sportsmen of merit are also considered for out of turn allotment of family accommodation. Outstanding sportsmen are also considered for award of Vishisht Seva Medal, Series of decorations and commendations from the respective Chiefs of Staff. In addition to these, limited financial assistance from non-public funds is given to Services sportsmen participating in the Services National International Championships to meet the cost of training, extra diet and other miscellaneous expenses.

No percentages has so far been earmarked for recruitment of sportsmen into the Services.

In respect of civilians of the Ministry of Defence they are governed by the normal provisions as applicable to all other civilian employees of the Government of India. However, in respect of civilians of the Ordnance Factories Board, Directorate General of Inspection and Directorate of Technical Development and Production (Air), the position is as follows:—

- (i) Certain percentage of vacancies are reserved for meritorious sportsmen in Group 'C' and Group D' as per the orders of the Department of Personnel and Administrative Reforms. The perfor sportsmen centage of reservation varies from 5 to 15 subjects to the overall ceiling of reserved vacancies not exceeding 50 per cent of the total vacan-In the Directorate General recruitment of meritorious Inspection, Group ,C, and sportsmen in are made without reference to Employment upto five advance increments are the Saff Selection Commission; and
