स्नातकपूर्व शिक्षा की व्यवस्था 'श्री गलाव कुनंबा ग्रायवेंदिक कालेज, जामनगर' में है जो इस विक्वविद्यालय का एक धंय है। स्नातकपूर्ण पाठकम में हर वर्ष 32 कालों को दाखिला दिया जाता है । ।त-कोत्तर जिल्ला जामनगर स्थित स्नास्मेनितर प्रजिक्षण एवं अनुसंधान संस्थान कोदी जाती है। स्नातकोत्तर पाठ्यक्रम में वार्षिक प्रवेश शमता 25 स्नातकोत्तर छात्र है। इस मंत्रालय द्वारा इस विश्वविद्यालय से उलीणं होकर निकलने वाले चिकित्सकी को रोआवगार देने के लिए कोई विशेष उपाय नहीं किये गये हैं।

JAFFAR SHARIEF): (a) and (b) The Chemists grade Rs. 425-700 (RS) or above have been declared as 'supervisory' under the Hours of Employment Regulations in accordance with the extant orders. As such, they are not entitled to the payment of overtime. Accordingly, the Chemists classified as 'supervisory' on Allahabad Division are not being paid overtime.

(c) The following categories of staff in grade Rs. 425-700 (RS) in other Branches are entitled to overtime payment if they are not holding

independent charge and not employed »»n mail¹ lly supervisory duties:

Under the scheme financial assistance is provided to these organisations for selected purposes, such as publication concerning consumer affairs, consumer education through exhibitions, seminars, workshops, film shows demonstrations etc., testing of consumer items, consumer complaint counters and such other activities which directly .or indirectly contribute toward₃ consumer protection movement.

Aligarh.

(b) It. is not feasible to provide trains in addition to the existing trains to cater to the commuter traffic in queustion in view of resource constrairrts with the Railways.
