The investment and locational decision in this regard are yet to be taken.

An application from Navrang Photo Films Private Limited for setting up a 100 per cent Export Oriented unit in District Kolar in the State of Karnataka for the manufacture of Cellulose Triacetate and various types of photo films including colour film, has also been received.
