Meeting between the Minister of State for Finance and Representatives of Mill Owners' Association of Gujarat

862. SHRI IBRAHIM KALANIYA: Will the Minister of FINANCE be pleased to state:

- (a) whether it is a fact that the Minister of State in his Ministry recently visited Gujarat and had discussions with the representatives of the Gujarat Mill Owners' Association and Gujarat Beopari Mahamandal about their problems; and
- (b) if so, what are the details in this regard?

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI PATTABHI RAMA RAO): (a) Yes, Sir.

(b) A pre-budget Memorandum dated 14-2-83 seeking certain concessions, both in direct and indirect taxes, has been submitted by Ahmedabad Textile Mills' Association for consideration.

Discussion between Officials of Central Govt. Employees' Association of Gujarat and the Minister of State for Finance

863. SHRI IBRAHIM KALANIYA: Will the Minister of FINANCE be pleased to state:

(a) whether it is a fact that during the recent visit of the Minister of State in his Ministry of Gujarat representatives of Employees belonging to Income Tax and Customs and Central Excise Departments met him and discussed their problems and submitted memoranda to him; and

(b) if so, what are the details in this regard?

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI PATTABHI RAMA RAO): (a) and (b) During he recent visit of Minister of State for Finance to Ahmedabad (Gujarat), the Gujarat Income Tax Employees Association, Ahmedabad and the Income Tax Notice Servers' and Group 'D' Employees Association, Gujarat submitted their memoranda to him. The first one is an Association recognised by the Government. The other Association has not so far been recognised by the Government.

The Gujarat Income-tax Employees Association, Ahmedabad have requested the Minister:—

- (i) to sanction more posts in the cadres of I.T.O. Group 'B' Inspectors, Notice Servers and Group 'D' Staff for Gujarat Charge;
- (ii) to have a time-bound schedule for solving the accommodation problem of the staff of the Gujarat Charge; and
- (iii) to give powers to the regional
  Heads of Departments to make direct recruitments of staff instead of Staff Selection Commission

The Income-tax Notices Servers and Group 'D' Employees Association has made the following demands:

(i) Recognition of the Association;

- (ii) sanction of more posts of Record Keepers and Notice Servers for Gujarat Charge.
- (iii) increase of washing allowance from Rs. 4 to Rs. 10 per month.
- (iv) revision of pay scale of Jama-dars
- (v) timely supply of liveries etc. to Group 'D' staff and notice Servers.
- (vi) supply of cotton (mill made) uniforms instead of khadi.
- (vii) increase in the strength of Peons.
- (viii) grant of medical allowance in place of medical facilities provided by CGHS.
- (ix) provision of more residential accommodation for Peons and Notice Servers; and
- (x) stoppage of deduction of 10 per cent as House rent from their pay.

No Association of Customs and Central Excise Employees met the Minister.

## Promotion of Tourism

864. SHRI AMARPROSAD CHAK-RABORTY: Will the Minister of TOURISM AND CIVIL AVIATION be pleased to state;

- (a) whether it is a fact that tourism industry of India ranks today as the second biggest foreign exchange earner:

THE MINISTER OF STATE IN THE MINISTRY OF TOURISM AND-CIVIL AVIATION (SHRI KHUR-SHED ALAM KHAN): (a) Foreign exchange earnings from tourism as estimated by this Ministry ranked third after export earnings from handicrafts & engineering goods.

(b) and (c) The Ministry of Tourism and Civil Aviation in their mid-term review of the Sixth Five Year Plan had requested for the enhancement of the Sixth Five Year Plan outlay from Rs. 25 crores to Rs. 38 crores. No decision has yet been taken in this regard.
