THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI PATTABHI RAMA RAO): (a) and (b) The total investment in terms of Gross Block

on the modernisation of the on-going projects of the Central Public Sector undertakings and on the new industrial unit_s in the Central Public Sector set up in West Bengal during the last 3 years ended 31-3-1982 was of the order of Rs. 894.79 crores. Bulk of this investment, in terms of the priorities of the Sixth Plan (1980-85), was on modernisation of th_e existing projects.

Arrests under COFEPOSA & FERA

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI PATTABHI RAMA RAO): (a) ana (b) The number of persons datained under the COFEPOSX Act during the year 1982 is 443 as' against 265 persons detained during the year 1981. There is no provision in the Act for search and seizure.

The Enforcement Directorate (Foreign Exchange Regulation Act) seized Indian and Foreign currencies of the value of Rs. 1.36 crores and arrested 101 persons during the year 1982. The corresponding (figures for the year 1981 are Rs. 1.14 crores and 110 person_s respectively.

The value of *prime-fade* unaccounted assets seized by the Income-tax authorities, during the course of searches in the years 1982 and 1981 are Rs. 27.59 crores and Rs. 29.95 crores respectively. There is no provision in the Income-tax Act for arrest of persons during search and seizure operations.
