## Solution of Inter-State River Water **Disputes**

## 1066. SHRI INDRADEEP SINHA: SHRI SURAJ PRASAD :

Will the Minister of IRRIGATION be pleased to state:

- (a) whether it is a fact that a number of inter-State river-water disputes are pending amongst the various State Governments;
- (b) if so, what are the details of such. disputes; and
- '(c) whether Government propose to set up a River Board for quick and effective solution of these disputes?

THE MINISTER OF STATE IN THE MINISTRY OF IRRIGATION (SHRI RAM NIWAS MIRDHA): (a) and (b) There are only two major inter-state river water disputes pending at present, which relate to the use and development of:

- (1) Cauvery Basin amongst the States of Karnataka, Kerala, Tamilnadu and the Union Territory of Pondicherry; and
- (2) Yamuna Basin amongst the States of Haryana, Uttar Pradesh, Rajas-than, Himachal Pradesh, and the Union Territory of Delhi.
- (c) There is no such proposal before the Central Government at present. The matters are being pursued through mutual negotiations and discussions.

THE MINISTER FOR RAILWAYS (SHRI A. B. A. GHANI KHAN CHAU-DHURI): (a) Yes.

(b) Speicfic complaints of corruption are investigated into by the Vigilance Organisation. Preventive checks of sensitive areas of working are undertaken as a continuous measure in order to prevent and eradicates corruption/malpractices. In specific cases of proven responsibility, disciplinary action is taken under the rules. Measures for improvement in procedures and systems. wherever necessary, are recommended to the executive departments concrned in order to enable them to plug loopholes in areas prone to corruption. The activities of the Vigilance Organisation cover all Department of the Railway. During 1981-82, 1539 preventive checks were conducted over the Eastern Railway and 768 complaints were Investigated Based on vigilance reports recommendations 366 railway employees were punished during 1981-82 including seven cases of removal from service.
