## Hazards of sub-standard pesticides

## ◆185. SHRI A." G. KULKARNI: SHRI SURESH KALMADI;

Will the Minister of AGRICULTURE be pleased to state:

(a) whether Government are aware of the newspaper reports appearing in the Times of India' of 14th and 15th December, 1982, regarding the hazards in use of pesticides of sub-standard quality and >f so what are the details thereof;

(b) whether it is a fact that such reports are periodically floated by the multi? nationals to protect their own interests for import of their products only and by discouraging Government from allowing more capacity to be created for the production of pesticides in the country; and

(c) if so, whether Government propose to create a reliable monitoring authority to protect the interests of the farmers against such abuses?

THE MINISTER OF AGRICULTURE (RAO BIRENDRA SINGH): (a) A series of three articles on hazards from pesticides appearing in "The Times of India" on 15th, 16th and 17th December, 1982 have come to the notice of the Government.
