THE MINISTER OF STATE IN THE OF MINISTRY SHIPPING TRANSPORT (SHRI Z. R. ANSARI): (a) Yes, Sir. The State Govt, had indicated in a report that work has been taken up on this road by them.

- (b) and (c) So far, no proposal has been received from the State Govt, for construction • of a tunnel through Peer Panchal Range. The only proposal sent by them provides for construction of a road over Pir-Ki-Gali pass at a cost of Rs. 15.87 crore*.
- (d) The matter has been under correspondence between the Central Government and the State Government for quite sometime. The alignment of the proposed road over the Pir-Ki-Gali along the Old Moghul route was approved by the Defence Ministry who had at no Stage objected to it. In case an alignment at a lower level along with a tunnel is contemplated now, this wiH have to be examined afresh from the security angle since these two aspects were not covered under the earlier clearance.

Brain drain of personnel of Merchant Navy

- (b) whether it is a fact that these Officers soon after putting in the minimum years of service leave the Shipping Corporation or other Government Companies/Organisations and join the foreign shipping lines, which offer remunerative salaries and perks; and
- (c) if so, what measures Government propose to take to check this brain drain and loss of money on training?

Navigating/Marine Engineering Cadet i» Government run Merchant Navy Training Institutions is Rs. 28,000 and Rs. 42,000 respectively.

- (b) For several years in the past ft large number of trained and qualified navigating and Engineering Officers have been leaving the service of Indian Shipping Companies to take up employment on Foreign Flag Ships which offered lucrative salary and other perks. Of late this tendency has considerably reduced due to world wide recession in shipping. There is no shortage of officers for Indian Shipping Companies at present.
- (c) Government have powers under Section 87(a-d) of the Merchant Shipping Act to regulate employment of Indian Officers on Foreign Flag Ships.

Amount spent on the improvement of National Highways

- (a) the total amount spent on the improvement of the National Highways, particularly the Delhi-Jaipur-Ajmer Ahmedabad Highway passing through Rajasthan during the current year;
- (b) whether this Highway i_s in a bad condition at some places owing to high density of vehicular and other traffic on account of the ever-increasing use of the Kandla Port; and
- (c) if so, what action tn proposed to be taken to further improve it during the next year?

THE MINISTER OF STATE IN THE MINISTRY OF SHIPPING AND TRANSPORT (SHRI Z. R. ANSARI): (a) Out of an allocation of Rs. 600 lakhs for National Highways (Original) works for Rajasthan during 1982-83, a sum of Rs. 417.77 lakhs has been spent on improvement/development of National Highways in Rajasthan upto December, 1982 which inter-alia includes a sum of Rs. 247 lakhs incurred on Delhi-Jaipur-Ajmer-Ahmedabad National Highway No. 8 passing through Rajasthan.
