## Road User Cost Study by the Central Road Research Institute

1275. SHRIMATI SAROJ KHAPAR-DE: WiH the Minister of SHIPPING AND TRANSPORT be pleased to state;

- (a) whether it is a fact that the. Central Road Research Institute in its road user cost study has stated that about Rs. 1500 crore could be saved in fuel consumption and wear and tear of vehicles on Indian roads in each year; and
- (b) If so, the details of the study made by the Institute and steps suggested to save the money?

THE MINISTER OF STATE IN THE MINISTRY OF SHIPPING AND TRANSPORT (SHRI Z. R. ANSARI): (a) and (b) In the Road User Cost Study carried out by the CRRI o.n behalf of the Government, various aspects such as wear and tear of vehicles, vehicle operating cost and savings in fuel consumption etc., as related to road geometries and road roughness and speeds have been carried out. Quantification of total savings has, however, not been worked out. The study has not yet been fully completed and the Government is yet to take a view on the report.

## Adoption of Villages for Socio-economic Development

(a) whether there is any proposal under Government's consideration to make concentrated efforts for the socio-economic development of backward rural areas on the basis of voluntary adoption of villages by officials and nan-officials organizations;

- (b) if so, what are the details thereof;
- •(c) what is the number of villages in each State adopted by each Organization so far;
- (d) what central assistance is being given to such organizations;
- (e) in what manner these villages are being developed; and
- (f) whether the Central Government have prepared any guidelines for the development of these villages, if so, what are the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI ARIF MOHD. KHAN): (a) The adoption of villages primarily aims at (i) to bring about the general increase in agricultural production and thereby to raise the income of ihe rural community and (n) to ensure optimum development of the villayes so that they become models of development for the neighbouring areas.

- (b) The programme of Adoption of Villages envisages that the village to be adopted should have a population ranging from IOO—200 farm families with large percentage of small and marginal farmers. Besides, the villages should be adopted preferably in those areas where some Central and State Government programme on crops, animal husbandry, fishries or irrigation are in operation.
- (c) According to available information, 3975 villages have been adopted in difftrent States by various agencies, such as Agricultural Universities/Research Institutions/Research Stations, General Universities, Fertilizer Industry Units, Departments of the State Governments/Union

Territories, Cooperative Banks, Voluntary Organisations etc. etc. The State-wise number of villages adopted by various agencies is as under:-
