THE DEPUTY MINISTER IN THE MINISTRY OF INFORMATION AND BROADCASTING AND IN THE DEPARTMENT OF PARLIAMENTARY AFFAIRS (SHRI MALLIKARJUN): (a) and (b) No, Sir. A Regional Office of Directorate of Advertising and Visual Publicity is being set up at Gauhati only.

Creation of National and Regional Power Grids

- (a) the progress made so far in regard to the creation of a National Power Grid:
- (b) the estimated capital outlay involved and whether it will mature partially in the next Plan:
- (c) whether the system envisages linking of regional grids with the National Grid, if so, what is the possible location of the National Grid and its linkage with the regional grids; and
- (d) whether Rajasthan which is suffering from acute shortage of power resulting in huge industrial and agricultural production loss will be considered for locating a regional grid to be fed by the National Grid?

THE MINISTER OF STATE IN THE MINISTRY OF ENERGY (SHRI CHANDRA SHEKHAR SINGH): (a) to (d) Government of India have accepted in principle, the need for development of a Centrally owned National Power Grid. However, electricity being a Concurrent subject, the mechanics of creating the Grid are being worked out in consultation with the State Governments, State Electricity Boards, through a continuous dialogue.

While the National Power Grid, as envisaged, will encompass the entire country, including Rajasthan, complete details are yet to be worked out.
