(b) and (c) The National Programmes which are relayed by the AIR Stations average 4 hours per week excluding centrally broadcast news and topical discussions. The rest of the time in each Station

is devoted to local programmes. The actual language|dialect-wise programme time for the different AIR Stations are not compiled.

The sanctioned budget of the Festival was Rs. 60 lakhs. However, information regarding revenue is yet to be compiled.

(d) Although a number of officials visited foreign countries for attending various film festivals abroad during the year 1982, as per statement enclosed, no individual was specifically deputed abroad in connection with the IX IFFI.
