Nationalisation of Bengal Potteries

•264. SHRI LADLI MOHAN NIGAM: t

SHRI KALYAN ROY:

WiU the Minister of INDUSTRY be pleased to refer to the reply to Starred Question 72 given in the Rajya Sabha on the 7th October, 1TO2 and •tate:

- (a) whether any decision has been taken to nationalise the Bengal Pot teries Ltd. which has already been under the Industrial Reconstruction Corporation of India;
- (b) if not, what are the reasons therefor;
- (c) whether Government are aware that a recent enquiry has revealed incidence of massive corruption and malpractices and fraud by some of the senior officials and if so, what are the details in this regard;
- (d) whether a senior officer dealing with finances was recently found removing many files surreptitiously;
- («) what is the name of the officer and whether he has been chargesheeted or allowed to resign; and
- (f) what is the number of new employees and workers recruited during the last six months and the details thereof including their departments and their qualifications?

THE MINISTER OF STATE IN THE MINTSTRY OF INDUSTRY (SHRI VTRBHADRA SINGH): (a) and (b) The Industrial Reconstruction Corporation of India Limited (IRCI) which is the 'Authorised Person' for the management of the units of Bengal

Potteries Limited, has constituted a Committee of Directors to study *interalia* the viability of the unit. A decision with regard to the future disposition of the undertaking will be taken on receipt of the report of the Committee and the recommendations of the IRCI in this regard.

- (c) A preliminary report in thii regard has been received by the IRCI and the matter is under further verification.
- (d) The management has reported that no official files/documents were removed.
 - (e) Does not arise.
- (f) The information is being collect ed and will be laid on the Table *at* the House.

श्री लाडली मोहन निगम: सभापति महोदय, असल में ग्राज में इस सवाल के जवाब को घमा फिरा कर देने की कोशिश की गई है। मामला यह है कि बंगाल पोटरीज जो चीनी मिटटी के बरतन बनाती है उसमें एक लम्बे समय से घोटाला चल रहा है और इसके चलते सरकार ने यह समझा कि इस कम्पनी को ले लें। बयोंकि भगत साहब जो ये वह यहां पर वारा-न्यारा करते थे । हुआ यह कि जब से गवनंमेंट ने इसको टेक भ्रोवर किया है; टेक्स्रोवर करते वक्त करीब-करीब 44 लाख रुपये जो देनदारी के थे उसका सरकार ने भगतान क्या और उसके बाद 162 लाख रुपये भरकार ने और भी दिये। मैं यह जानना चाहता हुँ कि क्या यह सही नहीं है कि जिन गन्दगी की बजह से जिन खराबी की वजह से शापने कम्पनी ली थी उसी आदमी को वहां पर एक जीक्य टिव डाय-रेक्टर बना दिया ? यही नहीं आपको तो मालुम होगा कि हिन्दुस्तान का जो सबसे बढ़ा स्थयालगार कलकता क्लब

है जिपकी मेम्बरी श्राज भी लगभग 3 लाख रुपये प्रिमियम की है उसका मेम्बर इन्होंने उसको बनाया श्रीर उसका सारा खर्चा यह उठाते हैं और उसके बाद हम उम्मीद करें कि सम्भमो याटे में न चले यह कैसे हो सकता है। मैं एक ही बात जानना चाहता है इसका जवाब मंत्री जो हो या न में दें। क्या यह सही नहीं है कि सन् 1980-81 में फैक्टरी का उत्पादन करीब 43 परसेंट था जो घट कर 1982 में 29 परसेंट रह गया ? यह एक फैक्टरी नहीं ऐसी कई फ़ैक्टरियां हैं । दूपरो फ़ैक्टरी भी इसी तरह से हैं जहां 59 परसेट से षट कर 39 परसेंट हो गया ।

एक तरफ तो प्रोइक्शन में घटाप याया योर दूसरी तरफ खन्नों में बढ़ोतरी हुई । ये सब वर्ते अधके पास दर्ज होंगी । मैं जानना चाहता हं कि ये बातें सच हैं या नहीं ? उसके बाद जो एकजीक्युटिक डाइरेक्टर है उनके संबंध में अन्तरिक लेखा परीक्षण में, इन्टरनल बाडिट रिपोर्ट में, श्रनियमि-मितताएं बताई गई, लेकिन ग्राप उनके बारे में बामोश बैठे हुए हैं मैं जानना चाहता हं कि वे अनियमितताएं क्या है भीर जिन लोगों ने ये अनियमितवाएं की है उनके खिलाफ ग्रापने क्या कार्यवाही की है ? 31 जनवरी, 1982 को इस संबंध में मंत्री जी ने कुछ बातें बताई थीं। इस प्रधार से स्पष्ट भूमिका बताने ने बाद मेरा प्रश्न यह है कि क्या था। जी० ने० भगत, जिनको वजह से इस कस्यनी की हालत इतनो खराव हुई ग्रीर जो सर-कार के मल्ये पढ़े हुए हैं, इस आदमी के खिलाफ वयः श्रापने कोई कार्यवाही की है ग्रीर क्या ग्राप उनको हटाने जा रहे हैं ? इतके साथ-साथ में यह भी जानना चाहता हं कि जो उत्पादन घटा उसके लिए जो लोग जिम्मेदार हैं उनके बारे में क्या आप कोई जांच करेंगे ? इसके अलावा अन्त-रिक लेखा परोक्षण में जो ग्रनियमितताएं बताई गई हैं, जिन-जिन श्रादिमयों को दोषो

बताया गया है उनके खिलाफा प्राप कोई कार्यवाही करेंगे या नहीं भीर यदि कोई कार्यवाही करेंगे तो कब तक करेंगे?

श्री समापति : इसका जुवाब पहुने होने दीजिए, उसके बाद दूसरा कवाल पाछए ।

SHRI VIRBHADRA SINGH: Sir, the Bengal Potteries Limited whicii was a sick unit was taken over by the Government under the IDR Act and the IRCI was appointed at the autho rised person. The IRCI in turn ap pointed a Board of Management and Shri G. K. Bhagat who has been refer red to here just now was appointed as the Executive Director. So far aa the performance of the company i* con cerned, it has not been very satisfac tory and it i« true -----

As I have just pointed ou:, there is no doubt that the performance of th* company has not been very satisfactory and this company has been incurring loss year after year. In 1978-80, the company suffered a losi of Rs. 70.56 lakhs. In 1980-81, the losa was Rs. 67.16 lakhs. In 1981-82, it is estimated that the loss would be Rs. 306.21 lakhs and in 1982-83, the loss is likely to be Rs. 380 lakhs. Thi* is from July to June, as the financial year of the company ends in June. Aa regards the allegations to which the hon. Member ha_s referred, the IRCI, which is the authorised pe son m respect of this company appointed K. Roy and Company as the financial controller. The financial controller has given a preliminary report on certain irregularities in regard to purchaseof coal and coke and sale of insulators. They are being further verified by the IRCI.

SHRI VIRBHADRA SINGH: Sir, the question of nationalisation is under the consideration of the Government.

भी लाडली मोहन निगम: मंत्री महोदय ने कहा था कि 14 मार्च तक ले लेंगे। SHRI VIRBHADRA SINGH: Let me complete my answer.

SHRI SURESH KALMADI: You have given an assurance in this House. Mr. Tiwari has given an assurance. Why he is not answering?

SHRI VIRBHADRA SINGH: Please listen to me. If you are not satisfied, you can ask further questions.

Sir, the IRCI has constituted a committee of its directors to go into this matter and the terms of reference of this committee are to find out the potential viability of the BPI, to make out an estimate of the cost involved in making the unit viable and to undertake a full investigation into the affairs of the company. The decision in regard to the future dispensation of the undertaking will be taken on receipt of the report of the committee and on recommendations of the IRCI in this regard. The report is likely to he received by the end of April. It is only after receipt of this report that we will be able to take any decision in the matter.

श्री लाडली मोहॅन निगम : पहले जो ग्राख्वासन दिया था क्या वह गलत हैं?

SHRI SURESH KALMADI: Mr. Tiwari had given an assurance, Sir.

SHRI KALYAN ROY: This company was actually under liquidation in 1975. In 1976 the IRCI took it over and Mr. Bhagat took Rs. 8 crores from the Punjab National Bank which was

written off. After it was taken over by the IRCI, the new Board made Mr. Bhagat who was responsible for mismanagement, the chief executive director. The entire control is under him and since 1976, a_s per the reports given in this House, the Punjab National Bank gave Rs. £.74 crores and the IRCI gave Rs. 2.25 crores. Nearly Rs. 11 crores have been sunk and the production, as has been stated, is constantly going down. The overhead, cost which was Rs. 18.42 lakhs, in 1978-80 has gone up to Rs. 26 Iakhs in 1980-81. In factory No. 2 it has gone up from Rs. 3 crores to Rs. 8 crores. These are the overhead costs while the production has been continuously declining. And there was no financial controller. After I met Mr. Mukherjee in his chamber and gave a representation, he said that there would be an investigation and the investigation has pointed out all the irregularities. A_s a result of this what' has happened? This financial controller was found taking all the files in the presence of Mr. Bhagat and giving them to the driver. The entire employees of the office have given it in writing. After getting it in writing, they allowed Mr. Deepak, the financial controller, to give resignation and he has come to Delhi to pressurise Shri Narayan Datt Tiwari and others. There was no question of enquiry, etc.' Meanwhile the period of takeover has been...

MR. CHAIRMAN: Are you asking a question? (*Interruptions'*). Then where is the question?

SHRI KALYAN ROY: Is it not a fact that only on the 7th October, 1982, without referring to any enquiry, Mr. Tiwari categorically stated in Rajya Sabha that the period of takeover has been extended up to 14th March, 1988, by which a decision i_s going to be taken? There .was no question of enquiry at that time. How doe_s the question of enquiry come in now? I« it because of the allegations? All the allegations have been proved and they dare not produce before the House what are the irregularities. I have a photostat copy of the letter written

by the Chairman of the Bengal Potteries to Shri Bhagat dated December 3, 1982, in which it is stated; "I express my anxiety about the en.ire episode and I convey to you my total disappointment of the method, followed which amounts to cheating." This is a challenge of the chairman of tha board of the Bengal Petteries. I have given a copy of this letter to Mr. Tiwari, to Mr. Finance Minister. The result is that they gave extension.

MR. CHAIRMAN: Mr. Kalyan Roy, you have said enough. The question is a very short one which you have asked that it was said that by the 14th of March the decision could be taken. Three days have passed and what has been done is the short question instead of all this lecture.

SHRI KALYAN ROY: Is it because Mr. Bhagat is very powerful, because he is carrying a lot of influence with the Minister of Industry to scuttle the nationalisation proposal, to handover the entire factory to him?

SHRI NARAYAN DATT TIWARI: Sir, I am not aware of the influence of Mr. Bhagat. I do not know Mm, he has met me once only for a few minutes, (Interruptions')

SHRI KALYAN ROY: He has admitted that he has met him.

SHRI NARAYAN DATT TIWARI: As my hon, colleague has just said, all these matters are being enquired into by the board of directors of the IRCI and they have set up a special committee, a commit'ee consisting of Shri C. R. Sen Gupta, Chairman, Shri Hiten Bhaya and Dr. A. Sitaramaiah, to look into these particular matters. As soon as the report is received, we shall take a decision about the future of this company.

SHRI SADASHIV BAGAITKAR: Is there any time limit for the report?

Already 14th of March has been flouted. Your own assurance is already fXouted_k (Interruptions)

SHRI KALYAN ROY: I would like to know whether there is any time limit. We do not know why suddenly this Committee has been formed by the IRCI against whom there are charges?
