#### **Belgian Metal Working Industry**

1881. SHRI R. R. MORARKA: Will the Minister of INDUSTRY be pleased to state:

(a) whether the Belgian Metal Working Industry has expressed its readiness for tie-ups with the Indian firms; and

(b) if so, what is the progress made in this regard?

THE MINISTER OF INDUSTRY (SHRI NARAYAN DATT TIWARI):  
(a) Yes, Sir.

(b) Contacts have been established between the Belgian Metal Working Industry and various Indian organisations for cooperation in specific areas of engineering industry. These, include telecommunication, refrigeration plants, textile machinery, chemical process plants, industrial valves, hydraulic turbines etc.

#### **Communal riots in the country**

1883. SHRI N. P. CHENGALRAYA NAIDU:  
SHRI NAND KISHORE BHATT:

Will the Minister of HOME AFFAIRS be pleased to state:

(a) whether there have been large number of communal riots in Bihar, Trivandrum and various other parts of the country during November-December, 1982 and also in 1983;

(b) whether in Trivandrum the communal riots took place frequently during 1982;

(c) whether the Home Minister and the Defence Minister visited the riot affected areas;

(d) if so, what was their assessment;

(e) what help was provided to the States by the Centre to deal with the riots; and

(f) the number of cases in which army was called to maintain peace at these places?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI NIHAR RANJAN LASKAR): (a) There have been some communal incidents in Trivandrum and some other places in the country during November, December, 1982 and 1983. There were no serious incidents in Bihar during that period.

(b) No, Sir.
