### **Loan for Machinery**

1992. SHRI BHAGATRAM MANHAR: Will the Minister of INDUSTRY be pleased to state:

(a) what are the details and the names of the companies who have received loans for the purchase of machinery from the National Small Scale Industries Corporation during the year 1982;

(b) whether Government have given loans to some of the companies and entrepreneurs for setting up biscuit factories; and

(c) what are the details of the parties and from where the plants were purchased with their prices etc.?

THE MINISTER OF STATE IN THE MINISTRY OF INDUSTRY (SHRI VIRBHADRA SINGH): (a) The National Small Industries Corporation does not give any loans for the purchase of machinery. However, it supplies machinery on hire-purchase basis to Small Scale entrepreneurs.

(b) Central Government does not give any loans directly to companies and Small entrepreneurs for setting up Small Scale industries.

### **Bird Sanctuaries**

1993. SHRI BHAGATRAM MANHAR: SHRIMATI MANORAMA PANDEY:

Will the PRIME MINISTER be pleased to state:

(a) whether it is a fact that many bird sanctuaries in the country are getting dry due to drought;

(b) if so, what are the names of such bird sanctuaries and whether these sanctuaries have not attracted birds from distant countries due to drought; and

(c) what **are** the steps proposed to be taken by Government for the development and improvement of the ponds and lakes in these sanctuaries so that these could attract birds next year?

THE DEPUTY MINISTER IN THE DEPARTMENT OF ENVIRONMENT (SHRI DIGVIJAY SINH): (a) and (b) No reports have been received from any State so far, of bird sanctuaries drying up permanently due to drought.

(c) The State Governments of the drought affected States have already been advised to ensure that proper arrangement for water supply is made for the wildlife in the sanctuaries and national parks, particularly during the dry season.

### **Serving of Indian Soft Shelled Turtles as Dishes**

SHRI BHAGATRAM MANHAR:

Will the PRIME MINISTER be pleased to state:

(a) whether Government has received some reports about the serving of Indian soft shelled turtles as dishes in various hotels and restaurants **in** the country;

(b) if so, what are the names of such hotels serving this dish; and

(c) what steps Government are contemplating to take to preserve this species of wildlife in the country?

THE DEPUTY MINISTER IN THE DEPARTMENT OF ENVIRONMENT (SHRI DIGVIJAY SINH): (a) No, Sir. However, live turtles being transported on railway wagons to Calcutta have been apprehended.

(b) Doe\* not arise.

(c) The Indian Soft Shelled Turtle is included in Schedule I of the Wild Life (Protection) Act, 1972, and is thus under legal protection from hunting as well as from trade and commerce.

#### Crime in South Delhi

1995. SHRI GANAPAT HIRALAL BHAGAT: Will the Minister of HOME AFFAIRS be pleased to state:

(a) whether it is a fact that cases of rape, arson, kidnapping and pickpocket etc. have increased during the

last two years in South Delhi, particularly in areas like Lajpat Nagar, Kalkaji and Defence Colony;

(b) if so, what are the details of cases registered in these areas during the last two years;

(c) whether Government propose to transfer some of the officials of the police (stations in these areas specially the SHOs and DSPs; and

(d) if not the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI P. VENKATASUBBAIAH): (a) and (b) Two statements (I and II) indicating the crime figures for the South Distt, and also for the Police Stations Lajpat Nagar, (Kalkaji and Defence Colony for the year 1981 and 1982 are attached. While there is marginal increase under some heads, there is over all decline in the crime reported in South Distt, and in these three police Stations.

(c) and (d) No such proposal is under consideration for the present.
