(b) The shortfall in foodgrains production during the kharif season has been due to the adverse effect of severe and extensive drought in different regions of the country as also floods and cyclones in some State. The Government have mounted a vigorous rabi compaign to offset as far as possible the losses in kharif production and to this effect have taken steps to make available critical input₃ such as diesel, power, seems, fertilizers, pesticides etc. to the farmers. The import of wheat mentioned in Part— (a) will also strengthen the foodgrain reserves with public agencies.

Release of foodgrains under the **National Rural Employment Programme**

- (d) whether the Ministry have been seeking full utilisation reports regarding funds and foodgrains both from the States before proceeding with the next stage of release;

- (f) whether this Programme is be ing misused by the States; and
- (g) if so, the steps taken or pro posed to be taken to check the mis use?

THE MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOP-MENT (SHRI HARI NATH MISHRA): (a) to (g). Release of resources under NREP are made on utilisati§» of at least 50 per cent resources given to the States earlier under the programme. However, taking into account the gap between the issue of release orders in respect of foodgrains and their actual supply to the executing agencies, release of second instalment of foodgrains during 1982-83 was made in case of some tSates, where utilisation reported was near 50 per cent utilisation. The programme is being implemented by the State Governments generally in accordance with the guidelines issued, and cases of deviations, if any, are brought to their notice for appropriation action.

Under IRDP the target group of beneficiaries are assisted to acquire productive assets which will enable them to increase their income. Any economically viable activity can be taken uP under the IRD Programme in the primary, secondary and tertiary sectors. In the Sixth Five Year Plan upto February, 1983, 5,75,869 beneficiaries have been assisted in Bihar.
